Dated Lahore, the 21st January, 2011.

The Chief Justice and Judges are pleased to post Mr. Muhammad Shafiq, newly recruited Civil Judge-cum-Judicial Magistrate at Kehror Pacca vice Mr. Muqarram Hussain since transferred in the public interest.

Note:

1. The officer shall assume charge of his office at his place of posting on or before 25.01.2011.
2. The officer shall report to the office of the Registrar on 24.01.2011 who shall administer Oath to the officer.
3. The officer, after joining at the station, shall not deal with any case independently instead he will receive training in civil/criminal work for fifteen days with the Senior Civil Judge/Judicial Magistrate Section 30 at the District Headquarter in order to acquaint himself with the practical functioning of the Court. He will note down arguments in all the cases already fixed for arguments and which are heard by the courts concerned. He will also go through the case law and the judgments delivered by the Presiding Officers. When the Senior Civil Judge/Judicial Magistrate Section 30 is not holding Court, the officer will work with the Nazir and Clerk of Court to the Senior Civil Judge and also Civil/Criminal Ahlmad to get himself acquainted with the office procedure and will prepare his notes of the training.
4. The officer will submit his declaration of asset alongwith documentary proofs duly signed by him to the District and Sessions Judge concerned, who after fulfilling the requirements in light of the instructions circulated by this Court from time to time, shall transmit the same to Lahore High Court, Lahore.
5. After completion of training, the officer will be interviewed by the District and Sessions Judge concerned, who shall submit report of his assessment for record.
6. After completing the training for fifteen days, the officer will work at his place of posting independently.


